You should complete this application if:

2. The terminal illness is likely to result in life expectancy of less than 2 years.
3. The family you are representing lives in Scotland. Please note we cannot accept applications directly from parents, carers or families. If you are a family and you feel we may be able to help, please ask your social worker, nurse or medical professional to complete this application on your behalf.



How to apply

1. Complete the enclosed form fully with or on behalf of the family.
2. Ensure the parents sign in three places on pages 5, 8, and 11.
3. Ensure parents read and sign the appended GDPR privacy statement which makes it clear how we will store and use the data and information provided.
4. You must include a covering letter giving appropriate information and this **MUST** be on your organisation's headed paper.

1. Information we collect about you

1.1 We will collect personal information from you when you or your organisation enquire about our events or fundraising activities. This may include your name, title, email address, postal address, telephone numbers and job title. We will only collect personal information (or 'data') from those who directly interact with us: supporters, donors, fundraisers, event attendees, volunteers, referrers (or potential referrers), parents and carers (and/or those who make enquiries), children who use our services, and those who use our website.



2. Use of information

2.1 Your personal information will only be used to process your requests, and to provide you with information relating to our events and all other fundraising activities.

2.2 We will share your information with our partners and other carefully selected organisations which we think may be of interest to you.
